TERMS AND CONDITIONS

Responsibilities and liabilities :

They act only in the capacity of agents for the passenger in all matters pertaining to accommodations , sightseeing tours and transportation whether by plane or motor coach, and as such they shall not be liable for any personal injury, death, damage ,loss , accident, delay or irregularity which maybe occasioned either by reason of any defect in any vehicle, or through the acts or default of any company or person engaged in conveying the passenger, or in carrying out the arrangements of the tour or otherwise in connection therewith.

Under no circumstances is CommongroundD to be held responsible for: a) Baggage damage, loss, or delay in delivery. b) Delays, personal injury, property damage or any loss resulting from any acts of God, act of public enemy, arrest or restraint of any government, seizure under legal process, quarantine, restrictions, riots, or civil commotions, strikes, lockouts or labour stoppages , war hazards or dangers incident to a state of war, participation in sports activities or performances arranged by CommongroundD c) Improper or insufficient passports or other documents d) Loss of personal property, possessions or monies. f) Any act of neglect of any person or company whose services are retained by CommongroundD for the benefit of tour participants including, but not limited to hotels, tour agencies, transportation companies and tour guides. g) Any deviation, delay or curtailment of any kind, however caused, and if beyond the control of CommongroundD.

CommongroundD reserves the right to cancel, change or substitute any service, and to decline to accept or retain any tour member at any time for any reason including insufficient number of participants. Air carrier is responsible only for the air travel portion of the tour performed by them on behalf of the tour participants in accordance with terms and conditions of the individual passage contracts and subject to applicable laws, treaties, and regulations governing transportation. The aforementioned condition shall also apply in regards to any other means of transportation connected with these tours. The usual passage contract used by carriers, when issued shall constitute the sole contract between airline and participant.
